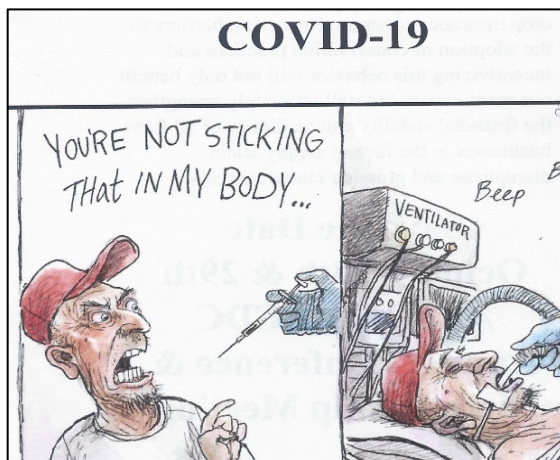
All members are to be on the conference call during the election, but a member cannot hold an office if she has not paid fees in full. Members support your chapters and call in. There is no excuse for not participating.
